SUBJECT: AWARD OF CONTRACT: PURCHASE OF TWO NEW END-DUMP TRUCKS

RECOMMENDATION:

It is the Administration's recommendation that the School Board approve and authorize the Superintendent to award a contract for the Purchase of Two End-Dump Trucks to Alaska Truck Center in the amount of \$202,962.

PERTINENT FACTS:

The contract award for the Invitation to Bid is for the purchase of two (2) end-dump trucks for the Anchorage School District Maintenance Department. This equipment was approved by the voters on Proposition 4 in April 2004. They will be used for snow removal, hauling heavy equipment, fill and topsoil at schools and facilities throughout the District.

An Invitation to Bid for the Purchase of Two End-Dump Trucks was issued on July 2, 2004. Two bids were received on July 20, 2004. The low responsive bid was submitted by Alaska Truck Center in the amount of \$202,962.

The Anchorage School District has previously purchased equipment from Alaska Truck Center.
