At their meeting last night, the Anchorage School Board approved the revised 2003-2004 school year calendar for Village Charter School. This calendar complies with current state law SB 239 that allows for a school term to be not less than 150 days if approved by the Commissioner of Education and "that includes at least 740 hours of instruction and study periods for pupils in kindergarten, first grade, second grade, and third grade and at least 900 hours of instruction and study periods for pupils in grades four through twelve." Section 1 of this Act is retroactive to July 1, 2003.
