Elementary Attendance Incentive Promotion Terms And Conditions

1. Prizes are only open to eligible participants. An eligible participant is an Anchorage School District (ASD) student enrolled in and attending an ASD school where attendance is officially recorded and who meets attendance criteria set forth below. Students enrolled in ASD homeschool programs are not eligible for participation. Additionally, students whose parent and/or legal guardian is or was involved in the planning of the promotion or drawing of the winners shall be excluded from participating in the promotion.
2. There is a total of one (1) prize of a Disneyland vacation to be awarded at the kindergarten level. Eligible participants for this prize are kindergarten students who have no unexcused absences for the 2013-14 school year. For contest purposes only, absences will be tracked beginning on September 3, 2013.
3. There is a total of one (1) prize of a Disneyland vacation to be awarded at the fifth or sixth grade level. Eligible participants for this prize are fifth and sixth grade elementary students who have no unexcused absences for the 2013-14 school year. For contest purposes only, absences will be tracked beginning on August 21, 2013.
4. There is a total of one (1) prize of a Mac computer, model to be determined by IBEW. Eligible participants for this prize are all elementary school students, as defined in Term and Condition No. 1, with no unexcused absences for the 2013-14 school year. For contest purposes only, kindergarten and first grade student absences will be tracked beginning on September 3, 2013; all other elementary students will have absences tracked beginning on August 21, 2013.
5. For purposes of participant eligibility, an unexcused absence is defined by the Anchorage School District in its attendance policies and procedures. Contest eligibility is based solely on a student's official attendance record.
6. For each prize identified, one winner will be drawn at random from those students who meet the eligibility criteria as of May 15, 2014.
7. Because the students are minors, prizes must be accepted by a winning student's parent or legal guardian.
8. If unable to contact a winner after two days of attempts, or should the winner be unable or unwilling to accept the prize and agree to the terms and conditions of the media release and liability release within two days of notification, the prize will be awarded to an alternative winner, drawn in accordance with contest rules.
9. The vacation prizes include only those services and attractions identified. The winner is responsible for any additional expenses, including additional meals and drinks, excursions, attractions, car rental, travel insurance, treatments, and personal expenses.
10. The vacation prizes, including all components of those prizes, are subject to availability and travel must be completed during days school is not in session and no later than December 31, 2014. Dates and flight times are subject to availability at the time of booking.
11. All elements of the prizes are non-transferable, non-refundable, and there are no cash alternatives. The prizes cannot be sold or given to an alternative party.
12. The winners and their families will be required to sign a media release to participate in the promotion. In addition, by accepting a prize, each winner and their families agree that IBEW, School Business Partnership (SBP), and/or ASD have permission to use their names and images for future promotional purposes and without compensation.
13. The winners and their families will be required to sign a liability release to participate in the promotion. In addition, in accepting the prizes, the winners and their families knowingly and voluntarily agree to release from liability IBEW, ASD, and SBP, and their respective Boards, employees, and agents, from any and all claims, damages, or suits, no matter the type of claim, that arise from or are related to the Elementary Attendance Incentive Promotion or its prizes, including but not limited to any injuries or damages associated with travel.
14. The prizes include only those items identified. The winner is responsible for paying and reporting any additional expenses, including taxes and fees, associated with winning and receiving a prize. The value of the prizes may be reported for tax purposes as required by law. If requested, the winner must provide IBEW with a valid taxpayer identification number or social security number before the prize is awarded. Failure to provide such identification will result in forfeiture of the prize.
15. Events may occur beyond the control of IBEW that render the awarding of the prizes impossible. IBEW reserves the right to cancel or amend the prizes without notice and the participants agree that no liability or claim exists against IBEW, SBP, or ASD as a result of any changes to or cancellation of the prizes.
16. Promotional materials for the Elementary Attendance Incentive Promotion, including detailed descriptions of the prizes, form part of these terms and conditions.
17. IBEW is responsible for providing prizes and for working with the winning families on receipt of the prizes and travel arrangements. ASD is responsible for identification of students eligible for the prizes and for conducting the random draws. SBP is responsible for working with both IBEW and ASD to promote the Elementary Attendance Incentive Promotion to ASD elementary students and their families.

Student requirements

- ✓ Drive and Fly for Perfect Attendance is open to ASD high school students, excluding district homeschool programs.
- ✓ Student must be enrolled full-time, as defined by district reporting requirements, beginning the first day of school 2013.
- ✓ To qualify for Level 1 prize, student must attend every day he or she is enrolled. To qualify for Level 2 prize, student must attend every day of the quarter.
- ✓ Attendance criteria is based on ASD's standard reporting method.
